REQUEST FOR RELEASE OF FUNDS

On or about August 6, 2019, Wayne county *will* submit a request to the **HUD/ The Department of Urban and Community Development, 477 Michigan Ave. 16th Floor, Detroit, MI 48226** for the release of Community Development Block Grant Funds under the **Housing & Community Development ACT 1974**, to undertake a project known as Public Services in the cities of Allen Park, Brownstown Twp. Ecorse, Flat Rock, Garden City, Gibraltar, Grosse Pointe Farms, Grosse Ile, Grosse Pointe Park, Grosse Pointe Shores, Grosse Pointe Woods, Hamtramck, Highland Park, Huron Twp. Inkster, Melvindale, Northville, Plymouth, Plymouth Twp. River Rouge, Riverview, Rockwood, Romulus, Southgate, Sumpter Twp. Trenton, Van Buren Twp. Wayne, Woodhaven and Wyandotte in the amount of \$20,000.00 of the 2019 CDBG allocation.

FINDING OF NO SIGNIFICANT IMPACT

The **Wayne County** has determined that the project will have no significant impact on the human environment. Therefore, an Environmental Impact Statement under the National Environmental Policy Act of 1969 (NEPA) is not required. Additional project information is contained in the Environmental Review Record (ERR) on file at Wayne County, 500 Griswold, on the 28th Floor - Detroit, MI 48226 and may be examined or copied weekday's 9 A.M to 5 P.M.

PUBLIC COMMENTS

Any individual, group, or agency may submit written comments on the ERR to the Wayne County. All comments received by August 6, 2019 will be considered by the **Wayne County** prior to authorizing submission of a request for release of funds. Comments should specify which Notice they are addressing.

OBJECTIONS TO RELEASE OF FUNDS

HUD will accept objections to its release of fund and the **Wayne County** certification for a period of fifteen days following the anticipated submission date or its actual receipt of the request (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer of the **Wayne County**; (b) the **Wayne County** has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR part 58; (c) the grant recipient has committed funds or incurred costs not authorized by 24 CFR Part 58 before approval of a release of funds by HUD; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted in accordance with the required procedures (24 CFR Part 58, Sec. 58.76) and shall be addressed to the **U. S. Department of Housing and Urban Development –Detroit Field Office, Patrick V. McNamara Federal Building – 477 Michigan Ave. on the 16 Floor - Detroit, MI 48226-2592**. Potential objectors should contact HUD to verify the actual last day of the objection period.
