  - ii. <u>Proposed change:</u> The board may designate one or more committees, each committee to consist of one or more of the directors. <del>The committees shall not consist of a quorum or majority of the board.</del>
- b. Consider dissolving existing Sign Committee and Marketing Committee
- c. Consider establishing new subcommittees following the Main Street America structure:
  - i. Economic Vitality and Design Committee <u>Description of work:</u> improving the physical appearance of Joseph Campau, supporting historic building rehabilitation and adaptive reuse, setting design review guidelines and processes, analyzing current market forces, providing a balanced commercial mix, supporting and expanding existing businesses, recruiting new businesses, supporting housing options, developing infill space, and converting unused or underused commercial space into economically productive property.
  - ii. Organization and Promotion Committee <u>Description of work:</u> marketing an enticing image, directing and creating social media campaigns, organizing events (e.g. street festivals, parades, retail and other special events), fundraising, recruiting volunteers, establishing public relations, fostering collaboration between stakeholders, developing work plans to guide the organization's work.
- d. Consider assigning the following board members to each subcommittee:
  - i. Economic Vitality and Design Committee
  - ii. Organization and Promotion Committee
- e. Consider setting calendar dates and meeting times for subcommittees.

- f. Consider applying same attendance provisions for DDA board meetings to subcommittee meetings.
