

NOTICE TO RESIDENTS

2022 Residential Alley Reconstruction Program

Through a selective bidding process, the City of Hamtramck has awarded Dominic Gaglio Construction, Inc. of Huron Township, Michigan a contract to complete the reconstruction of several residential alley segments throughout the City of Hamtramck. You are receiving this notice as the alley near your home or business will be reconstructed, and work is anticipated to start on the alley near your home or business. It is anticipated that the alley will be closed for reconstruction for approximately six (6) weeks. It is anticipated that the reconstruction of the alley will take approximately four (4) weeks followed by two (2) weeks to allow for new concrete to cure prior to opening to traffic.

The attached map provides the locations of the alley reconstruction areas. The dates listed below are subject to change, due to weather and or other delays beyond the contractor's control.

Alleys 3, 5, and 6 will begin on Monday 10/3/2022 Alley 4 start date is Monday 10/24/2022 Alley 2 start date is	11/04/2022
Alley 7 start date is TBD	
Alleys 1, 8, and 9 start date is TBD	

During the course of the construction you should expect the following:

Traffic Control and Detours

11/04/2022 All vehicles must be removed from the alley no later than 7 am on_ per the schedule provided above to allow for the complete closure of the alley. In addition, any vehicles or equipment you may have stored in a garage or in your rear yard requiring the use of the alley must be moved prior to the start of the construction. Alleys will be closed to all traffic during the entire duration of the project. Any vehicles currently parked in the alleys will have to be relocated to the front of your property on the street or on an adjacent side street. Be aware the Hamtramck Police and Fire Departments are aware of the construction and precautions will be taken to continue proper protection of the neighborhood.

Dust Control

The Contractor, on a regular basis, will sweep adjacent side streets to alleys to control dust as much as possible; however, this will be an active construction zone, and dust will exist and should be expected.

Garbage Pick-Up

Garbage will continue to be picked up weekly on your normal pick-up day. However, all garbage will need to be placed in the front of your home next to the street to allow Priority Environmental to pick up all garbage. Priority Environmental will be notified by the City's Department of Public Services when construction will be taking place and that garbage will need to be picked up along the street and not in the alley. Another notice will be delivered to your attention when the alley will be re-opened to traffic and when garbage pickup will resume in the alley.

Working Hours

Typical working hours will be from 7:00 am to 6:00 pm Monday through Friday, with the potential of occasional work taking place on Saturdays if; however, at this time the Contractor does not anticipate working any Saturdays. **OVER**


