

**NOTICE OF PUBLIC HEARING  
CITY OF HAMTRAMCK  
(AMENDED APRIL 6, 2023)**

**PROPOSED SEWER AND WATER IMPROVEMENT PROGRAMS**

The City of Hamtramck will hold a public hearing for the Clean Water State Revolving Fund (CWSRF) and Drinking Water State Revolving Fund (DWRP) loan for the City of Hamtramck lead service line replacement and water system improvements program. The purpose of the meeting is to present the Clean Water and Drinking Water System Improvements and to receive comments from interested parties. The hearing will be held during the Hamtramck City Council starting at 7:00 pm on **Tuesday, April 25, 2023**. Interested residents may attend the meeting at the City of Hamtramck City Hall.

The purpose of the proposed project is to provide lead service line replacement as required by the Lead and Copper Rule (LCR) in June 2018 requiring all cities in Michigan to replace all lead water service lines. The water service lines must be replaced from the City-owned water mains within the street to 18 inches inside individual houses. Complete the Distribution Service Material Investigation (DSMI) at the remaining 230 locations. The water projects will involve water main replacement through a directional drill in one (1) location and pipe bursting of the existing water main in six (6) locations to upgrade the main in areas and not to disturb large sections of road, this work includes upgrading valves and hydrants in these areas. The estimated cost of all the projects is approximately \$15,685,528.00. The estimated cost to users for the proposed project will be \$13.53 per month.

The purpose of the Clean Water projects is to provide the continuation of the relief sewer beginning at the intersection of Joseph Campau and Goodson and to continue north along Joseph Campau to just south of Holbrook. In addition, a new 60-inch relief sewer will connect to the existing overflow structure at the intersection of Joseph Campau and Goodson and head west to the intersection of Lumpkin and Goodson to install a new overflow structure to relieve the existing Lumpkin drain. The preliminary design of the phase 2 relief sewer will be started to conduct flow testing, perform a hydraulic model, and design what is needed to relieve flooding in the northern portion of the city. Cleaning and Televising of the sewer will be performed to determine which sewers in the city shall be lined to maintain the structural stability of the sewer and provide an adequate level of service. The estimated cost of all the projects is approximately \$17,956,054.11. The estimated cost to users for the proposed project will be \$15.51 per month.

Copies of the project plan detailing the proposed projects will be available for inspection by the general public at the Office of the City Clerk, 3401 Evaline St, Hamtramck, Michigan starting Friday, February 24, 2023. Written comments received before the public hearing will close on **Tuesday, April 25, 2023, at 4:00 pm** and will be reviewed for incorporation into the final project plan. Written comments should be sent to the City of Hamtramck's Clerk's Office located at 3401 Evaline St, Hamtramck, Michigan.
