On June 28th there will be a dedication event at the park for the new monument. As part of the Juneteenth event there will be a march going from Sarah Garret Park to Veterans Park.

c. Hamtramck Neighborhood Arts Festival - Maria, Tim & Jetshri

Festival is being held on October 7th this year. New website will be going live within the next week, the poster art (by Sean Bieri) is ready to go as well as the forms for artist sign-up and the patronicity campaign to begin raising funds for poster and map printing. Maria is working on getting banners printed to advertise the festival along the route DCFC supporters use to get to and from the matches, and is working with Andy from Good Done Daily to create the graphics. There are plans to reach out to bike groups to do organized rides through Hamtramck on the day of the festival.

Julie Sailus (Hamtramck Resident in attendance) offered New Dodge Lounge as a location for the festival headquarters this year, as well as a gallery location for the schedule of festival events.
