#### A. Public Hearing on the Following Proposed Zoning Amendments:

- **b.** Amendment that allows for all other site plans to be approved by the Planning Commission as needed, rather than by City Council.
- **c.** An amendment to change the minimum floor area in a single-family dwelling unit from 800 square feet (SF) to 600 SF and the approval process for dwellings less than the proposed minimum required floor area in the R, Residential District
- **d.** An amendment to change the minimum floor area in an apartment house dwelling unit from 700 SF to 500 SF and the approval process for dwellings less than the proposed minimum required floor area in the R, Residential District.
- e. An amendment to allow apartment houses in the C2, Multi-Use district.
- **f.** An amendment to allow for and regulate accessory dwelling units in the R, Residential district.
- **g.** An amendment to reduce the number of members on the Planning Commission from nine (9) to seven (7).
- **h.** An amendment to reduce the number of members on the Zoning Board of Appeals from seven (7) to five (5).
