All signs: Up to 20 square feet \$125.00

Over 20 square feet \$250.00

An investigative fee equal to the permit fee, shall be assessed if a permit was not **issued** prior to commencement of work.

The following must be included on the sign permit application:

- Length of building frontage.
- Dimensions of proposed sign.
- Depth of proposed sign.
