OVERVIEW

The City of Hamtramck is conducting a silent auction to sell properties acquired by right of first refusal from Wayne County. Applicants are invited to submit bids starting on September 15th until the auction closes on October 2nd at 10:00am. Bids will be opened publicly on October 2nd at 10:00am in the City Council Chambers of Hamtramck City Hall.

All bids must meet four qualifications. 1) Buyers must repair and bring the property up to code or construct a new unit within two years of purchase. 2) Buyers must confirm that the planned development will be owner-occupied 3) Buyers must have the ability to close the sale within 48 hours of the auction ending date. 4) There is a fee of \$50 for each bid submitted.

The city will award sales to the highest qualifying bids.

BID REQUIREMENTS

Applicants must agree to the following four requirements to qualify.

Qualification 1: The buyer must repair the housing unit up to code or build a residential unit within two years of purchase.

Qualification 2: The buyer must purchase the property for himself or herself or for an immediate family member, and the home must be owner-occupied when complete.

ceptable Types of Owner-Occupied Housing:

- A. Home, single-family detached, owner occupied.
- B. Home, multi-family, owner occupied.
- C. Home expansion (neighboring lot owner-occupant purchases lot with a plan for home

expansion, such as the addition of new floor space or additional bedrooms)

Qualification 3: The buyer must close on the sale within 48 hours of the ending date of the auction using certified funds (e.g., cashier's check, money order, or certified check).

Qualification 4: The buyer must provide a \$50 fee for <u>each bid</u> submitted at the time of submission. Fee must be submitted at time of the bid delivery but separately from the envelope containing the sealed bid. Fees will only be accepted in cash, certified check or money order; no personal checks. Fee is non-refundable.

INSTRUCTIONS TO BIDDERS

- 1) Fill out the bid application form on page 4 for each property you intend to bid.
- 2) Include a bid price at or above the minimum price identified in the table above.
- 3) Place each application in a **sealed envelope** labeled in the following manner:

RIGHT OF FIRST REFUSAL RESIDENTIAL PROPERTY AUCTION BID [ADDRESS OF PROPERTY]

- 4) Include a copy of a state issued photo ID (Ex. state driver's license, passport, etc.) in the sealed envelope with the application.
- 5) Provide a \$50 fee for each bid submitted at the time of submission do not include inside the bid envelope, as envelopes must remain sealed. Bids received without payment of \$50 fee in cash, certified check or money order will be disqualified.
- 6) Submit a complete (sealed) application to the City Clerk's office before the October 2nd deadline at 10:00am. **Sealed bids with fee will only be accepted in person at the clerk's office in Hamtramck City Hall.** Applications received after this time will not be considered.

- 7) Applicants are welcome to, but are not required to attend the public bid opening.
- 8) If selected, a quit claim deed will be provided by the city upon full payment to the city treasurer's office.

BID SELECTION PROCESS

For each property, the highest qualifying bid will be selected. If multiple bidders bid the same price on the same property and are the highest bidders on that property, the bid received first will be selected. Any bid envelope that is not complete or that does not include the required information will be disqualified, even if it is the highest bid.
