- a. New Ideas, and discussion for 2024 (intro'd by each HAC Commission, and attendees partake)

 The commission would like to recruit more involvement from the community members for our subcommittees so we can have more input/work being done by more than just the limited number of commissioners allowed on the subcommittees.
- b. Hamtronic 2024, and what do start planning it (Tim)
 Last year Hamtramck had 4 locations. Tim is working his TV Lounge connections for next year.
 Meetings to plan will begin in January. Darren Shelton still will be involved in this event.
- c. HAC open Commissioner's seat is open. Jessi Kwek has applied (Tim)

 Hoping to have an update on Jessi Kwek's application at the city council meeting coming up to fill the current vacancy.

d. Subcommittee update on CED/City of Hamtramck's – Alley Project (Tim & Lynn) + merge with our Hamtramck Joe Louis Greenway

We want to make the alleyway an arts destination, not just murals

- Jessi Kwek will join this subcommittee
- Meetings will be held monthly starting in January
- Goals are for pr and marketing of why the bike lanes are good for local businesses and the
 community to change the current outlook on them, we don't want Hamtramck to miss out on
 being part of this historic greenway, it will attract people, and bring people to our city and
 businesses
- The subcommittee will reach out to HB (Joe Louis mural artist) to get permission to use image of his work in promotional materials
- e. Hamtramck DDA's website calendar, be liaison to Hamtramck Arts&Culture on it (Tim & Lynn)
 Hamtramck DDA is getting funding for a city calendar, this subcommittee will work with them to include arts & culture events
- f. Labor Day Fest (Tim)

For this year, want to ask to move the HACC booth to a location that gets better foot traffic, the booth can act as a sort of information booth for the event and the city

Recruiting other commissions to be involved in the booth has gone well, and other commissions may join next year

- g. Update on our <u>HACC</u> website, and launch new platform in June (Tim, and maybe Dusty) **Dusty and Tim will focus on the website and integration of the merchandising platform**
- h. Assist w/ curation, logistics & promotion of exhibiting art at City Hall (Tim)
